Terms and Conditions

1. **Exclusive Photographer.** The Photographer shall be the exclusive photographer retained by the client for the purposes of photographing the wedding. Family and friends of the client shall be permitted to photograph the wedding as long as they shall not interfere with the Photographer's duties.
2. **Deposit and Payment.** The Client shall make a non-refundable deposit in the amount of 40% of the total to retain the Photographer to perform the services specified herein. At such time as this order is completed, the deposit shall be applied to reduce the total cost and the Client shall pay the balance due. The remaining balance is due 14 days prior to the service date. If the Client refuses delivery of the order or refuses to pay prior to the balance due date, the Client shall be in default hereunder and shall pay 15% interest on the unpaid balance until payment is made in full.
3. **Cancellation.** If the Client shall need to cancel this Agreement before the wedding date, any payments made above the non-refundable deposit amount shall be refunded back to the Client.
4. **Photographic Materials.** The Photographer will make the proofs available on a website within 5 weeks from the wedding date. All photographic materials, including but not limited to negatives, proofs, and previews, shall be the exclusive property of the Photographer. The Photographer shall make proofs and previews available to the Client for the purpose of selecting photographs for an additional charge.
5. **Copyright and Reproductions.** The Photographer and client shall own the copyright in all images
6. **Photographer's Standard Price List.** The charges in the Agreement are based on the Photographer's Standard Price List. The price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
7. **Photographer.** The Photographer may substitute another photographer to take the photographs in the event of Photographer's illness or of scheduling conflicts. In the event of such substitution, Photographer warrants that the photographer taking the photographs shall be a competent professional.
8. **Failure to Perform.** If the Photographer cannot perform this Agreement due to a fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness, then the Photographer shall return the deposit to the Client but shall have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event the Photographer fails to perform for any other reason, the Photographer shall not be liable for any amount in excess of the retail value of the Client's order.
